**INFRACTION DEFERRAL AGREEMENT**

COMES NOW the State of Indiana by the Prosecuting Attorney for the 31<sup>st</sup> Judicial Circuit by his Deputy Prosecuting Attorney and the Defendant and enter into this Agreement pursuant to Indiana Code 34-28-5-1(f).

The State of Indiana agrees to defer prosecution and dismiss the charge(s) in this case IF AND ONLY IF, the Defendant complies with each and every term of this Agreement.

**SECTION I** The Defendant agrees:

- (a) To pay a non-refundable user's fee and statutory costs of:
  1. \_\_\_\_\_ \$20.00 for a three (3) month Adult Seat Belt Violation
  2. \_\_\_\_\_ \$89.00 for a three (3) month Non-Moving Infraction Deferral
  3. \_\_\_\_\_ \$189.50 for a six (6) month Infraction Deferral
  4. \_\_\_\_\_ \$249.50 for a twelve (12) month Infraction Deferral
- (b) To comply with any additional condition(s) imposed by the Court.

**AND** (c) That I will not commit any criminal offenses, moving traffic violation(s), non-moving traffic violation(s) or ordinance violation(s) during the deferral period.

**SECTION II** The Defendant affirms under the penalty of perjury, pursuant to I.C. 35-44-2-1, that the foregoing is true and accurate to the best of my information and belief.

- (a) That this violation(s) is not associated with ANY injury, property damage, accident or criminal charges.
- (b) That I have not been charged with a criminal offense or been issued a moving traffic violation, non-moving traffic violation, or ordinance violation within the last six (6) months in any State.
- (c) That the Defendant does not currently have a Commercial Driver's License (CDL).

THE DEFENDANT acknowledges that failure to comply with Section I and II of this Agreement may result in the Prosecuting Attorney immediately setting this case on the Court calendar. The defendant understands that this will result in the forfeiture of fees paid. Further, the Court can impose any additional condition(s) it feels appropriate. I have read and understand all of the provisions of this Agreement and I accept them as binding upon me and enter into this Agreement of my own free will.
