The R/P stated that the male provided her with an ID. The name on the ID is Emmanuel Hibber. The R/P stated that she took his ID and took a picture of it in her home. The R/P reported to me that she asked the male where his vehicle is located. The R/P stated that the vehicle was a house down. The R/P stated that it was a small silver vehicle with an Illinois license plate. The R/P stated that the vehicle had no decals or other indicators that the male was a consultant for Brinks Security. The R/P advised to me after the male left, she contacted ADT. The R/P was advised that ADT and Brinks Security are not a conjoined business. I advised the R/P to call ADT to verify the name on the badge.

## **Ordinance of the Week:**

### **Sec. 6-178 Discharge of Firearms Prohibited.**

After the legal passage, adoption, and publication of this ordinance, it shall be unlawful for any person, firm, or corporation to discharge or fire, or to suffer, permit, or allow to be discharged or fired, any pistol, gun, rifle, shotgun, air rifle, BB gun, or any other firearm whatsoever, including bows and arrows, within the municipal limits of the Town of Schererville, Lake County, Indiana, except as hereinafter provided.
