TOP 8 *Safe Driving Tips*



- 1** Plan your trip in advance.
- 2** Remember that speeding does not get you there faster.
- 3** Never drink and drive.
- 4** Pay attention to road signs and markings.
- 5** Never drive while tired.
- 6** Keep a 2 second gap between you and the vehicle in front of you.
- 7** Never get distracted by texting, eating, and likewise while driving. Stay focused on the task of driving safely.
- 8** Always reduce your speed while driving through a construction zone.

Natural Gas Meter Inspections

NIPSCO personnel may be in your neighborhood performing inspections and testing of natural gas meters.

These inspections are completed by NIPSCO contractors from GridHawk and RECONN. During your appointment, the technician will perform a safety inspection and a visual corrosion inspection of your meter. The inspection will take approximately 10 minutes. There is no charge for their inspection.

Please be advised that GridHawk and RECONN technicians carry photo identification, wear yellow high-visibility safety vests and drive marked vehicles. They may need to access your property to inspect your gas meter.

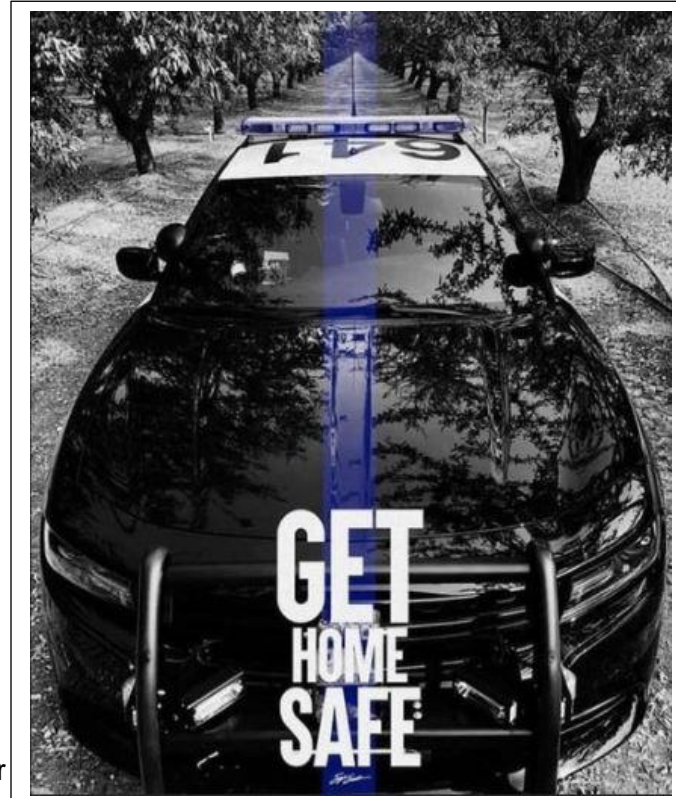

Ordinance of the Week:

Sec. 7-70 Display of Street Numbers Required.

Each building, house, or other structure on a parcel of real estate which is or has been assigned a street number by the Plan Commission, shall have displayed, and properly maintained thereon, the assigned street number on a portion of the structure on or near the main entrance, which is plainly and readily visible by the naked eye from the street or other public way which adjoins said parcel.
