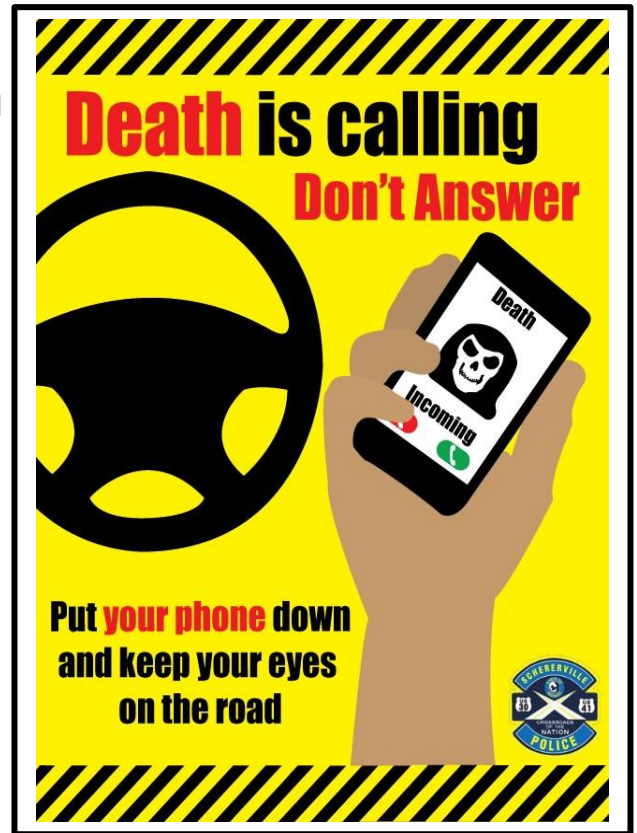

## **Ordinance of the Week:**

### **b. Vehicle Restricted to Roadways.**

1. No motorized vehicle of any kind shall be driven over or upon any portion of the park, except drives and roadways established for vehicles by the Board.
  
2. No moped bicycles shall be driven over or upon any portion of the park, except drives and roadways established for vehicles by the Board.

(Res. No. 88-4, § 7, 8-4-88 of the Park Bd. Res. incorporated into **Ord. No. 1267**, § 1, 1-26-94)
