Police Department

Chief Sormaz informed the Board the CALEA re-accreditation was completed on April 7, 2021, with the virtual on-site visit. All paperwork has been sent to the CALEA board for their recommendation, the results of which are still pending.

Chief Sormaz reported to the Board the Police Memorial will be held May 14, 2021 at the 911 Memorial between the hours of 6 am and 6pm.

Chief Sormaz advised the Board the Drug Take Back on April 24, 2021, netted 356 pounds (13 boxes) of unused prescription medicine.

Chief Sormaz reported to the Board the Patrol Ticketing Standard Suspension implemented in March 2020, due to Covid, has been lifted as of May 1, 2021. The Patrol Division is now at full gear.

Chief Sormaz reported to the Board that for the month of March, 2021, the Patrol Division had 1,176 calls for service, 88 accidents, 98 traffic citations, and 28 arrests.

Chief Sormaz further reported to the Board that for the month of April, 2021, the Patrol Division had 1,181 calls for service, 94 accidents, 151 traffic citations, and 43 arrests.

Chief Sormaz reported that for the month of April, 2021, the CID filed 69 criminal charges, 8 thefts, 0 thefts from motor vehicles, and 2 burglaries.

Fire Department

Chief Patterson stated construction has begun at Fire Station #3 in Pine Island and encouraged the Board to stop by and see the work that has been completed.

Chief Patterson reported that all reports were in the packet. For the month of April, 2021, the Schererville Fire Department performed 81 inspections, responded to 301 incidents and attended 461.75 hours of training.
