The Regular Park Board Meeting of the Town of Schererville, Indiana, was called to order by President Brad Bassick at 6:00 p.m. in the Schererville Town Hall, 10 East Joliet Street, Schererville, Indiana.

Attendance was taken with the following Board Members present: Brad Bassick, Tom Malinowski, Ed Repay, and Joe Skvarek. Staff members present: Superintendent John Novacich, Administrative Coordinator Irene Mireles, Attorney Christian Bartholomew, Councilwoman Robin Arvanitis, and Recording Secretary Kristen Bohling.

THEREUPON, Approval of minutes for March 3, 2021

Mr. Skvarek made a motion to approve the minutes from the March 3, 2021 meeting, seconded by Mr. Repay. All in favor (4-0).

THEREUPON, Reports

Mr. Novacich briefly went over upcoming events.

Mr. Novacich went over the progress of projects being done. He said the epoxy floor is finished at concession stand at Rohrman. Concession items have been ordered and the water has been turned on. Mr. Novacich also said a curb was poured around the new sign at Rohrman.

Mr. Skvarek asked Ms. Mireles about upcoming tournaments at Rohrman. Ms. Mireles said the NSA Tournament at the end of April will be one less day than originally discussed, due to low numbers. She also said the Schererville Baseball no longer needs to use Rohrman for their Memorial Day tournament, also due to low numbers. Mr. Novacich added that Girls Softball will also not be holding their Region Rumble Tournament.

ITEM A. Autumn Creek Disc Golf Course

Mr. Repay made a motion to allow Mr. Novacich to purchase nine targets and locks, at the approximate price of \$4,100.00, per the initial recommendation from the proposal. Mr. Skvarek seconded the motion. All in favor (4-0).

Mr. Repay amended his motion to include allowing Mr. Novacich to proceed with installation once the equipment is received. Mr. Skvarek seconded the amended motion. All in favor (4-0).

ITEM A. Consider Approval of Schererville Soccer Club Lease Agreement

Mr. Malinowski made a motion to accept the Non-Exclusive Lease Agreement with Schererville Soccer for 2021, with an amendment to Item 2A that the price of \$2,500.00 only be for one year, due to decreased usage in 2020. Mr. Repay seconded the motion. All in favor (4-0).

ITEM B. Consider Approval of NWI Church of Christ Rental Agreement

Mr. Repay made a motion to approve the Schererville Community Center Rental Agreement with NWI Church of Christ for the year 2021 with the rooms specified and the monthly payment equal to \$1,280.00. Mr. Skvarek seconded the motion. All in favor (4-0).

ITEM C. Consider Acceptance of NIES Engineering Proposal

Mr. Malinowski made a motion to accept the NIES Engineering Proposal for the 2021 Rohrman Park CDBG Improvement Project for \$19,350.00, seconded by Mr. Skvarek. All in favor (4-0).

ITEM D. Any other from Park Board

Mr. Malinowski said he would like to receive a monthly report for the Park Bond.

Mr. Skvarek requested the next meeting be at 7pm, instead of 6pm. The Board agreed.
