Mr. Poronto stated that residents have probably called and complained about the shrubs and growth around it, so the Town came out and chopped it all down so they could see the beautiful pond, which is slime green except for on the other end. The north end where he is looks like a slime bowl and now they have about fifty geese all over their yards. Mr. Poronto stated that something has to be done with that pond now, right now.
