He stated that they felt it was their responsibility, part of their obligation to do that report for the Council, to help you make your decision.

Mr. Johnson advised Mr. Reardon that he wanted to make sure he understood it was not something that was requested for them to do by administration or anyone, that this was something you took upon yourself to do and perform that analysis in your interpretation of your contract.

He thinks it's an extreme amount of money that the Town of Schererville is looking to spend on developing this property. Mr. Dean stated that the problem here is originally Reardon was granted \$93,000.00 or \$97,000.00 to do this. Then he came in and asked for another \$15,000.00 to do it and now it looks like there's another \$5,000.00. Mr. Dean stated he would like to know how much more money Reardon is going to be charging the Town of Schererville for this, and how much have they been paid already.
