Feeding feral cats can lead to an unsustainable increase in their population, according to the Schererville Animal Control Department. When food is readily available, these cats tend to reproduce more frequently, resulting in a higher survival rate for kittens.

This can lead to several negative consequences, such as increased disease transmission, a growing number of cats in the area and conflicts with neighbors due to noise and mess.

Here are some reasons to consider NOT feeding feral cats in our community:

- Population Explosion: Providing a consistent food source can lead to larger litters and higher survival rates for kittens, causing the local feral cat population to grow rapidly. We have already seen this happening in several subdivisions over the past few years.
- Impact on Wildlife: Feral cats often prey on native wildlife to supplement their diet. An increasing
 - cat population poses a significant threat to birds and small mammals.
- Health and Disease Risks: Feeding feral cats can attract more of them to the area, some of which may be unvaccinated. This can result in the spread of diseases and parasites among the cats and potentially to household pets.
- Attraction of Other Pests: Leaving food outside can also attract rodents and other pests, leading to various issues, including disease spread. If food is left out, many other wild animals may come to eat it as well.
- Neighbor Conflicts: An uncontrolled feral cat population can lead to problems such as spraying, fighting, and general messiness from food containers, creating tension with neighbors. Many residents are frustrated with the abundance of feral cats in the area and have reported concerns to animal control and the



police in an effort to stop people from feeding

Reliant on that Food Source: If the food suddenly disappears, they might struggle to hunt effectively, making them vulnerable.

By understanding these implications, we can work together to address the issue of feral cats in our neighborhoods more effectively.

How the Schererville Animal Control helps control feral cat population

The Schererville Animal Control partners with Pet Friendly Services of Indiana through their Community Cat Grant program, which supports the Trap-Neuter-Return (TNR) initiative for community (feral) cats. Throughout the year, we receive a limited number of vouchers for this program to aid our continued on back page

Snow removal involves team effort from everyone

Keeping our streets plowed and salted during snowfall events requires a team effort that includes the Public Works Department, residents and businesses. The Public Works Department is responsible for snow removal on approximately 115 miles of streets throughout Schererville. This doesn't include U.S. 30 or U.S. 41, which are maintained by the Indiana Department of Transportation State Highway Department.

Main roadways are plowed and salted first. These streets are usually pre-treated with a brine solution before a winter storm hits. This helps keep the snow from packing and freezing to the pavement. When plows are dispatched to begin plowing, they spread road salt behind each truck using a spinner. Drivers need to keep a minimum distance of 50 feet from the plow to avoid having the salt strike their vehicles.

After the main roadways are completed, the plows begin on the secondary tier streets, usually the main entrances into subdivisions. The Public Works Department finishes by completing the third tier streets within the subdivisions - streets that service the residents of that street and their visitors. The Public Works Department always attempts to keep these streets open, making one or two passes up and down them during a snowfall event. However, pushing the snow back to the curb line is usually not completed until the snow has stopped falling and the main streets and secondary streets have been completed.

Plow trucks must clear snow on streets to the curb line, and that sometimes causes snow to be plowed into cleared driveway entrances. The streets must be clear to the curb line to provide access for emergency vehicles, to provide mailbox access for postal carriers and to expose storm water inlets in case of a rapid thaw.

Cul-de-sacs present several challenges for the Public Works Department. They are wider than most streets which allow them to hold more snow. They also have more driveways. This leaves less area for the snow to be pushed to the side when clearing the road.

To help with snow removal efforts, we ask residents and businesses to NOT shovel snow from driveways into the street. The snow should be pushed to the sides of the driveway. Shoveling snow into the street causes ice patches, creating a hazard for drivers, and increases the amount of snow that may come back into your driveway during street plowing.

Please help keep fire hydrants clear of snow. This will assist the Fire Department if an emergency arises. Public Works employees are usually not available to do this until after the snow has been plowed from all streets.

As in the past, salt will continue to be spread on the main roadways. Or the second and third tier streets, salt will only be applied to the intersections, curves and hills. All drivers should use caution wher using the roadways under adverse conditions.

Town Ordinance 791 prohibits parking on the street when there is a snowfall of 2 inches or greater.

Your cooperation is always greatly appreciated so that the Public Works Department can maintain the streets in a safe, efficient and economic manner.



community in managing the feral cat population, available on a first-come, first-served basis. While our Animal Control Department doesn't address wild animals, we recognize that feral cats can present challenges, and we are working to tackle this issue.

If a Schererville resident wishes to report a problem with feral cats and is willing to help, please contact our Animal Control Officers at (219) 865-6992 to inquire about the availability of traps and vouchers. If we have these resources available, our Animal Control Officers will deliver a trap to the resident's home. The resident will then need to schedule an appointment with Munster Humane Indiana for the TNR procedure by calling (219) 922-3811.

After capturing a cat, the resident will transport it to Munster Humane Indiana, located at 421 45th Street. The TNR procedure includes sterilization, a rabies vaccination and ear-tipping, which serves as the



universal symbol of a sterilized and vaccinated outdoor feral cat. Once the procedure is complete, the resident must return the cat to its original location and release it.

We want to emphasize that Munster Humane Indiana provides exceptional service to the Schererville Animal Control Department. However, we are limited by the number of available vouchers throughout the year from Pet Friendly Services.
