The Regular Stormwater Board Meeting of the Town of Schererville, IN was called to order by President Caleb Johnson at 6:39 p.m., in the Schererville Town Hall, 10 E. Joliet Street Schererville, IN.

THEREUPON, Reports

Mr. Nondorf stated the he appeared before the Little Calumet River Basin Development Committee in November to perform a presentation requesting funding to add the three stormwater stations in Schererville to the SCADA telemetry system that the water department is currently working on. Mr. Nondorf stated that we received \$50,000.00 from the Little Calumet River Basin to help fund this project. He stated that he asked for 50% of the project which they weren't able to do, but they graciously gave us the %50,000.00 towards the project.

Mr. Schmitt asked Mr. Gorman if he has an update from the County on the ditch off of US 41, which runs alongside Andorra's banquet. Mr. Nondorf stated that the status is the same that he reported last month, no changes. Mr. Nondorf stated that they are also going to be doing work on the Dyer ditch along the new section of St. John Road. Both of these projects will be taking place in the spring. Mr. Schmitt asked if the ditch work on 65th Ave., all the way past the post office still scheduled. Mr. Nondorf stated yes, between CarX. He stated that is the eastern portion of the project and will take place and it will extend all the way to Janice Drive.
