ITEM A. Staff

Mr. Barnes discussed upcoming events in 2025.

ITEM A. Consider Approval of Donation Request – St. Michael's School

Mr. Novacich said there was a similar request last year for a donation of a dog park pass for 2025, as well as a large shelter rental request at Redar Park, for a silent auction event. Ms. Kelly asked what the monetary value of these donations would be. Ms. Morris said the dog park pass would be up to \$100.00. Ms. Bohling said the shelter rental would be \$180.00.

Mr. Skvarek made a motion to approve the donation request from St. Michael's for a 2025 dog park pass and large shelter rental. Mr. Repay seconded the motion (5-0).

ITEM B. Consider Acceptance of Fireworks Proposal

Mr. Novacich said the proposal is for this year's fireworks event, scheduled for June 27, 2025. He said the proposal is the same as last year, except the cost increased from \$31,000.00 to \$32,000.00.

Mr. Repay made a motion to accept the proposal from Mad Bomber for the fireworks event on June 27, 2025, for \$32,000.00. Mr. Skvarek seconded the motion. All in favor (5-0).

ITEM C. Consider Acceptance of 2025 Schererville Soccer Lease

Mr. Novacich said this year's lease is based on the discussions that were held last month during the study session. The terms of the lease are the same as last year's lease. Mr. Bassick requested that a note be made that about an increase in cost for next year.

Ms. Kelly made motion to accept the the 2025 Schererville Soccer Lease, seconded by Ms. Wilson. All in favor (5-0).

ITEM D. Any other from Park Board

Mr. Novacich said there was discussions with staff and Girls' Softball about increasing the fee for at least the next 3 years. The 2025 lease will be for \$3,900.00. Mr. Novacich said the rest of the terms are the same.

Mr. Skvarek made a motion to authorize staff to send a 2025 lease agreement to Schererville Girls Softball, in the amount of \$3,900.00. Mr. Repay seconded the motion.
