## ITEM A. PUBLIC HEARING

Mr. Troxell stated that he has approved the proof of Publications and find them in order.

Ord. #2021, An Ordinance Re-Establishing and Continuing a Comulative Capital Development Fund (CCDF) for the Town of Schererville, Lake County, IN, and all matters related.

Mr. Troxell stated that this is a Public Hearing to reestablish the Cumulative Capital Development Fund back to a nickel per 100 of assess value. He stated that it's currently at .0483, so a little less than a nickel. He stated that they established this back in 2022 when the rate dropped to a similar amount. Mr. Troxell stated that if the Ordinance is approved and adopted this evening a notice of adoption is required to be published one time in two newspapers. He stated that the notice of adoption starts the thirty day remonstration period where signatures from at least twenty five taxpayers is required for a valid objection. Mr. Troxell stated that if there is a qualified remonstration to this re-establishment, a special hearing will be scheduled.

Mr. Schmitt made a motion to consider on  $1^{\rm st}$  reading, Ordinance #2021, seconded by Mr. Johnson. All in favor (4-0).

ITEM B. Ord. #2013B, An Ordinance Amending Town 2025 Salary Ordinance No. 2013 Regarding the Salaries and Wages For Officials and Employees of the Town of Schererville, Lake County, Indiana, an Repealing all Town Ordinances or Parts Thereof, in Conflict Herewith

Mr. Gorman stated that the reason for his amendment is we're adding a few lines to the salary ordinance in the Fire Department clerical staff and recording secretary. This amendment also includes the Merit Board that was just established and the Merit Board Attorney.

Mr. Johnson made a motion to consider on  $1^{\rm st}$  reading Ordinance #2013B, seconded by Mr. Schmitt. All in favor (4-0).

Mr. Johnson made a motion to adopt Ordinance #2013B, seconded by Mr. Schmitt. All in favor (4-0).

ITEM C. Res. #2025-3, A Resolution of the Town Council of the Town of Schererville, Lake County, Indiana, Opposing Significant Cuts to Municipal Property Tax Revenues Without an Equitable, Comprehensive Replacement Mechanism.

Mr. Gorman stated that this resolution relates to the proposed property tax reduction proposed by the State. He stated that reducing property taxes would reduce our revenue which could lead to cuts across Municipal operations. Mr. Gorman stated that if this resolution is passed, we would send it down State saying that we're not in favor of this property tax reduction.

Mr. Schmitt made a motion to approve Resolution #2025-3, no second on the motion.

Mr. Schmitt made a motion to table this until next month's meeting, no second on the motion.

Mr. Johnson made a motion to deny Resolution #2025-3, seconded by Mr. Connelly. Mr. Guetzloff asked for a roll call vote. Mr. Johnson - Yes; Mr. Connelly - Yes; Mr. Schmitt - No; Mr.

Guetzloff - No. Motion tied 2-2. Attorney Austgen stated that Mr. Troxell may break this tie. Mr. Troxell stated that he is not going to vote on this item, and said we can bring it up at next month's meeting.

ITEM D. Consider Acceptance of Supplemental Agreement No. 2
Between DLZ Indiana, LLC and the Town of Schererville
Regarding Kennedy Avenue Improvements, Reducing
Compensation from \$2,060,265.00 to \$1,889,824.24, a
Decrease of \$170,440.76

Mr. Hansen stated that this portion, phase II, is Oak Street to Public Works. He stated the effort in scope of this and several of the tasks expanded through the course of the project. He stated that some task fees increased where we needed the right-a-way, however some of them were reduced. Mr. Hansen stated that the fees were decreased where possible. He stated the project fee overall decreased, so the total compensation to be paid to DLZ as outlined in the original agreement will be reduced from \$2,060,265.00 to \$1,889,824.24, so a decrease of \$170,440.76.

Mr. Johnson made a motion to accept Supplemental Agreement #2 between DLZ Indiana, LLC and the Town of Schererville, seconded by Mr. Schmitt. All in favor (4-0).

ITEM E. Consider Acceptance of Agreement between the City of Crown Point, Indiana and the Town of Schererville, Lake County, Indiana, Regarding Water and Sewer Regulatory Territories (From Utility Board Agenda)

Mr. Connelly made a motion to accept the agreement between the City of Crown Point and the Town of Schererville, seconded by Mr. Schmitt. All in favor (4-0).

ITEM F. Consider Annual Financial Contribution to the Tri-Town Safety Village \$36,400.00.

Mr. Jarvis, from the Tri-Town Safety Village stated that we're here to help save the children in the Towns of Schererville, Dyer, St. John and all surrounding communities. He stated that they teach more students than ever. He stated that students come to them for police, fire and railroad safety classes that improves their life expectancy in the communities that they abide in. Mr. Jarvis stated that with the support of the two other Towns, Dyer and St. John, they will make it so they can hit their budget for year 2025.

Mr. Schmitt made a motion to contribute \$36,400.00 to the Tri-Town Safety Village, seconded by Mr. Connelly. All in favor (4-0).

ITEM G. Consider Acceptance of Donations \$3,973.25.

Mr. Troxell read the donations into the record.

Mr. Connelly made a motion to accept the donations as read, seconded by Mr. Schmitt. All in favor (4-0).

THEREUPON, Business from the floor

Mr. Kevin Dean, 1905 Sir Richard Road, Schererville, Indiana stated that he was rather surprised on this Resolution 2025-3 and asked how much money Schererville is looking to lose if the State does this. He stated it says to curve it without an equitable comprehensive replacement mechanism. He stated that he is sitting here in the audience and listening to you create two positions that you're paying people, a lawyer and a recording secretary. Mr. Dean stated that he is very happy to say that since he's been coming to the Town Council Meetings and complaining about the Town Council giving away our funds to benefit things. He stated that he bought his house in May of 2022 and his mortgage payment was around \$2,200.00 a month and since that time, it's gone up to over

\$2,700.00 a month and the reason for that increase is basically my escrow, which means my insurance and property taxes are going up. Mr. Dean stated that if the State of Indiana wants to try and give him some benefit to where he can save some money for some other things, he's more in favor of that than the Town of Schererville trying to save some money.
