ITEM C. PD – CALEA Accreditation

Chief Sormaz informed the Board that on August 9, 2025, he and Corporal Ryan Staley, the Training Coordinator and CALEA Manager, traveled to Little Rock, Arkansas, for the Commission on Accreditation for Law Enforcement Agencies (CALEA) conference. During the conference, the Schererville Police Department was awarded Law Enforcement Accreditation for the fifth time. Chief Sormaz thanked everyone for their participation in the annual assessment.

ITEM D. PD – Time Promotions

Chief Sormaz requested approval from the Board for the time promotions from Probationary Patrolman to 1st Class Patrolman for Officers Devin Watkins, effective August 31, 2025, and Stephen Hawkins, effective September 14, 2025. He went on to add that both officers were hired during the Emergency Hire Process and joined Schererville with prior law enforcement experience. Additionally, he stated they had completed all necessary requirements during their probationary period. Motion made by Mr. Jaroszewski, seconded by Mr. Eenigenburg. The Board voted as follows:

ITEM E. PD – Proclamation National Rail Safety Week

Chief Sormaz informed those in attendance that National Rail Safety Week will be held September 15 – September 21, 2025. In addition, he stated the Department works closely with the Rail Police and thanks them for all the support they have provided over the years. Chairman Graf subsequently elaborated, stating Indiana was one of the first to implement a Rail Safety Week in the United States. He went on to present a condensed statistical data summary of railway accidents. Chairman Graf thanked all the local communities for their support for promoting railroad safety and awareness.

THEREUPON, Reports

ITEM A. Police Chief

Chief Sormaz informed the Board in addition to the reports submitted in the packet, he had been given a resignation letter from Keith Hickok, whom had unexpectedly resigned last month due to personal matters. Chief Sormaz wished him luck in his future endeavors. Chairman Graf requested Chief Sormaz convey the Board's gratitude for his service.

For the month of June, 2025, the Patrol Division responded to 1,553 incidents and took 85 accident reports. There were 113 total arrests. The Patrol Division filed 155 charges of which 63 were Class A Misdemeanors, 24 were Class B Misdemeanors, 45 were Class C Misdemeanors, and 23 were Level 6 Felonies. The Patrol Division served 72 total warrants. They performed 505 traffic stops resulting in 340 citations issued of which 115 were local ordinances and 225 were state infractions. 327 warnings were also issued. The Patrol Division performed 92 vehicle searches, of which 10 were K9 vehicle searches. There were 129 Proactive Patrols.

For the month of July, 2025, the Patrol Division responded to 1,770 incidents and took 85 accident reports. There were 139 total arrests. The Patrol Division filed 196 charges of which 69 were Class A Misdemeanors, 44 were Class B Misdemeanors, 49 were Class C Misdemeanors, and 34 were Level 6 Felonies. The Patrol Division served 97 total warrants. They performed 573 traffic stops resulting in 367 citations issued of which 99 were local ordinances and 268 were state infractions. 501 warnings were also issued. The Patrol Division performed 136 vehicle searches, of which 22 were K9 vehicle searches. There were 122 Proactive Patrols.

For the month of July, 2025, the Criminal Investigations Division (CID) filed 53 criminal charges which were the result of 19 cases. Of these charges, 23 were felony and 30 were misdemeanor. 34 were filed in Lake County Court, and 19 were filed in Schererville Town Court. The CID is investigating 67 incidents for the month of July. Detective Corporal Ian Segovia was the Detective of the month along with Officers Gerardo Garza and Scott Karras, whom are part of the Cross Trained Detective (CTD) program.

For the month of June, 2025, Schererville Police Officers attended 266 hours of training.

For the month of July, 2025, Schererville Police Officers attended 312.5 hours of training.

For the month of August, 2025, Schererville Police Officers attended 236 hours of training.

For the month of August, 2025, the Animal Control Division had 36 calls for service, 1 bite report and took in 7 animals.

ITEM B. Fire Chief

Fire Chief Patterson informed the Board he had no additional reports other than what was in the packet.

For the month of August, 2025, the Schererville Fire Department performed 61 inspections, responded to 342 incidents of which 279 were EMS related, 25 were Fire related, 35 were Alarms/Investigations, and 03 were Fire Prevention, Inspection and/or training. They also attended 693.01 total hours of training of which 351.15 were Fire Trainings, 265.86 were EMS Trainings, 16 were Leadership Trainings, and 60 were Community Training hours. 14 members recertified in Advanced Cardiac Life Support (ACLS), and 13 members recertified in Cardio Pulmonary Resuscitation (CPR).
