---

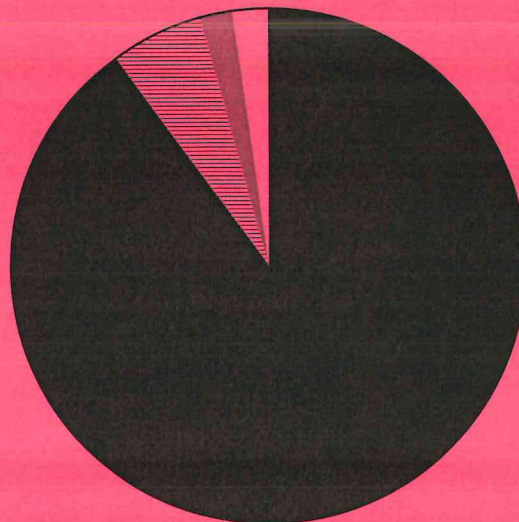
